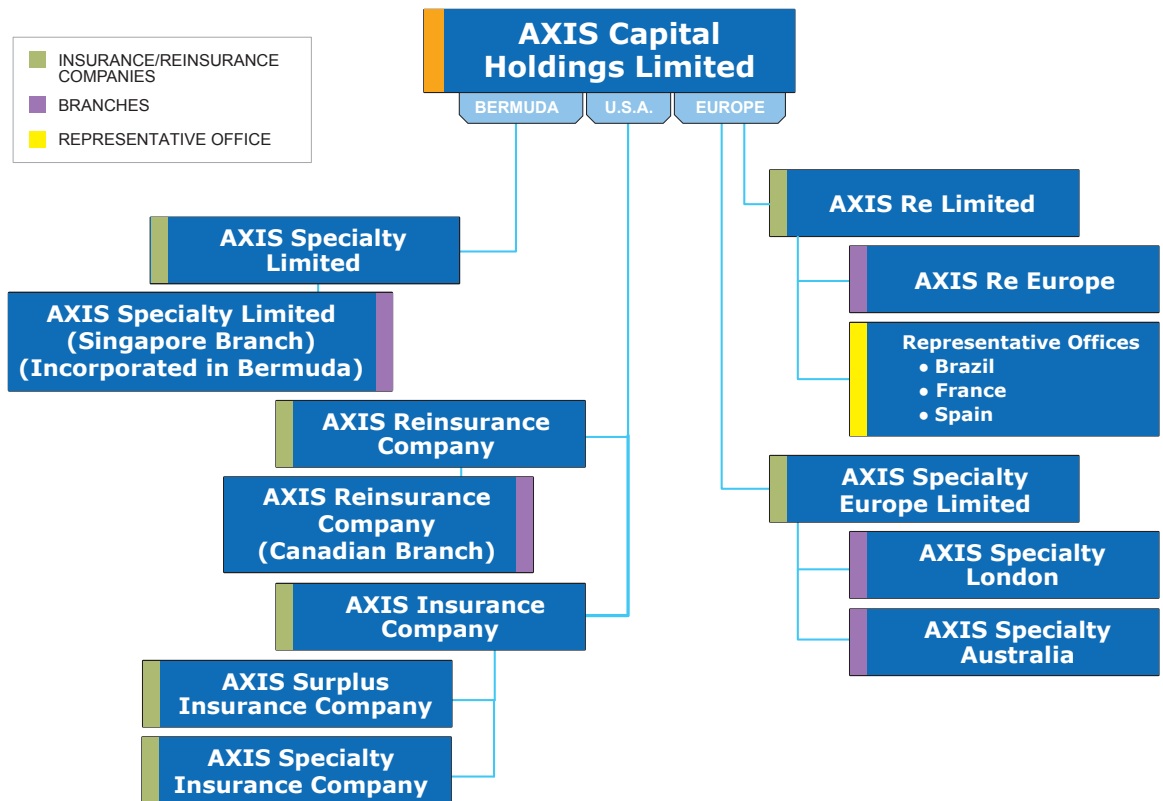




## Group Structure

AXIS Specialty Limited underwrites general insurance and reinsurance business, which broadly includes all types of coverages that are not long-term business. Long-term business broadly includes life insurance and disability insurance coverages with terms in excess of five years. General business broadly includes all types of insurance that is not long-term business. AXIS Specialty Limited operates globally on a non-admitted basis.

AXIS Specialty Europe Limited is also surplus lines eligible throughout the U.S. and may also transact insurance on a non-admitted basis globally.
